

<p>A 25 µl reaction in OneTaq<sup>®</sup> Standard Reaction Buffer in the presence of 200 µM dNTPs and 0.2 µM primers containing 10 pg Lambda DNA and 50 ng Human Genomic DNA with 0.625 units of OneTaq<sup>®</sup> Hot Start DNA Polymerase for 30 cycles of PCR amplification results in an increase in yield of the 2 kb Lambda product and a decrease in non-specific genomic bands when compared to a non-hot start control reaction.</p>
